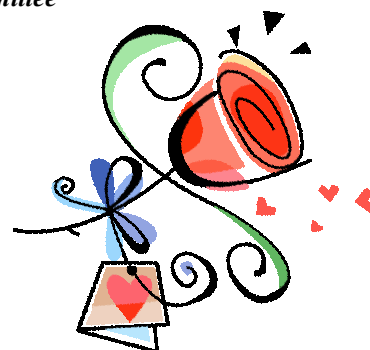

Knowledge Contest Reminders

The countdown to the State Contest at Assumption H.S. in Wisconsin Rapids began January 1st. Participating councils should have completed their Math and/or Spelling Contests by February 15th and have submitted their First Place winners and the number of participants at each grade level to their Diocesan Coordinator promptly!

1. "Double" winners in Math, Spelling or Free Throw Shooting must choose ONE event at the Diocesan level.
2. Winners advancing to the Diocesan Contest must be given a TRAVEL CARD to be shown at the registration table and to be used to gain admission to the contest room. The cards are to be collected after the contestants have filled out the cover

page of the contest booklet.

3. Efforts should be made to send an alternate (the 2nd Place winner) if the 1st Place winner opts out of the Diocesan Contest.

The place, date and times of all Diocesan Contests must be made known to all participating councils so that NO eligible contestants miss their opportunity to compete!

The Tour de Kalahari A Monthly Serial of Membership Recruitment

Stage Seven – "A Challenge in 'God's Country'"

[A brief Overview... By the end of Stage Six, a cold, but short marathon through the relatively flat region of the northern portion of the Badger State, Hull's Howling Heifers (Superior) were putting a firmer clamp onto first place. The four remaining challengers, though certainly not eliminated for a place on the podium and winner of the prestigious Yellow Jersey at the Champs de Kalahari at race end, were finding themselves in a tight struggle in this second tier of competition.

Up to this point, especially during Stages Five and Six the peleton has become significantly more tense. And the reason is primarily due to Team Rabbit. Early on, Mike "Soldier of Fortune" Angeli and Gary "Downtown" Brown were having difficulty in the proper strategy their potentially "killer of a team" should undertake. Lately, based on reports from the Sasquatch Associated Press Service (S.A.P.S.), Team Rabbit has shown modest though measurable surges placing them in a position to move out of fifth place. Now that we are entering yet another Climber's Delight along the majestic bluffs overlooking the mighty Mississippi River, will Team Rabbit make its charge? Let's listen as the Roving Yetis report the "goings on" for this "chain breaking" stage....]

Within a millisecond of Fr. Dave "The Arbitrator" Cooper ringing the starting bell, Team Heifer is in a breakaway up the first major climb of this mountainous stage along the westernmost boundary of Wisconsin. Reports from Roving Yetis indicate that Tom "The Sage" Rudolph, Dennis "Kingpin" Ashbeck, and Pat "The Kegster" Becker along with two expert climbers, Jim "Question Man" Otto and Jeff "The Tornado" Williams, are putting a lot of "blacktop" between Team Heifer and the remainder of the pack.

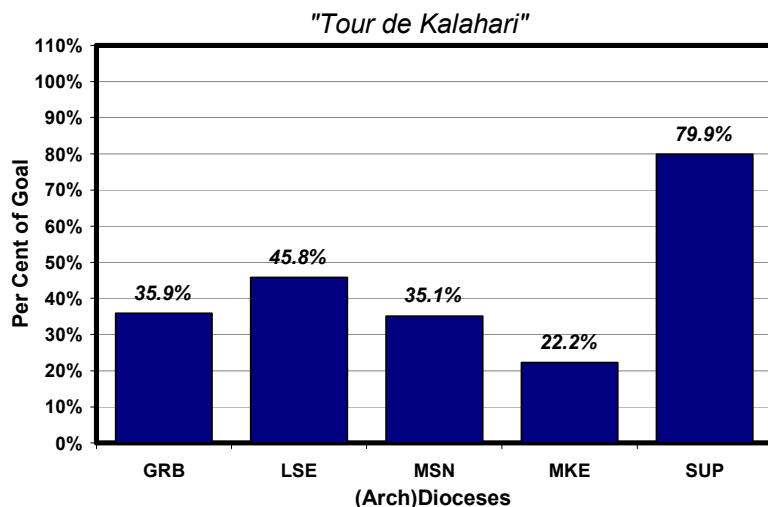
For the moment, in an effort to keep Team Heifer from making this a race for second place at this early stage, three of the four remaining teams are sending their expert climbers to make an attempt to help control the pace of this unprecedented "team breakaway" by Hull's Howling Heifers. From Guski's Galloping Gophers, Dan "The Matman" Matzek, who spends thousands of hours training on the very route this stage is now taking place, is not going to let Team Heifer get away "scot-free". Faust's Fastidious Ferrets and Ransom's Rabid Rabbits are also making a token effort to keep abreast of Team Heifer. They are sending Al "The Exterminator" Russell and Pat "The Mountain Mauler" Reiff, respectively. Although this loosely aligned triumvirate is putting up a valiant effort, at least for the moment anyway, it appears that these three climbers are only serving as a "light brake" for the high speed "Steam Engine", otherwise known as Team Heifer.

As an aside, it should be noted that of the three independent challengers, "The Matman", "The Exterminator", and "The Mountain Mauler", it is Pat "The Mountain Mauler" Reiff who bears some close watching in the future. This rookie has stepped up for Team Rabbit (Milwaukee) and, along with several other newcomers, is beginning to make observers, like this Sasquatch, have second thoughts about what was up to now considered to be a group of "under achievers". Mike "Soldier of Fortune" Angeli and Gary "Downtown" Brown have made some serious strides in bringing back what was once known statewide as "Rabbit Pride" to this seriously revamped team. But they still have a ways to go before they start pushing the present leader of this Tour!

Meanwhile, what has happened to Genthe's Growling Gazelles (Green Bay)? Unlike their three second tier competitors, no one from this team was sent to try to rein in the nearly solo team breakaway by Team Heifer. As we moved into Stage Six, Team Gazelle had made some small but significant strides by dragging themselves up to third place from a somewhat dismal fourth place showing early on. Dave "The Redneck" Hallada, Ed "Too Tall" Cross, and Geary "Spike" Spykerman along with the rest of Team Gazelle seem to have fallen flat on this "mountainous" stage.

Based on Roving Yeti reports it looks as though they have decided, at least for this particular leg of the race, to hunker down and, as best they can, maintain their present position. But by being conservative, it appears they have slipped further behind the second place Team Gopher (La Crosse) and are now only seconds in front of Team Ferret (Madison), which is now in fourth place.

Could this "conservative approach" spell doom for Team Gazelle? And even though Team Gopher, Team Ferret, and Team Rabbit did push their "climbers" to limit the dramatic team breakaway by Hull's Howling Heifers, their effectiveness was hardly measurable. Can this dynamo, known as Team Heifer, be challenged? Stage Eight may prove to be a leveler. This stage will mark the final set of team time trials in the 2009/2010 version of the Tour de Kalahari. Stay tuned for more answers next time....



If your Council GK or Membership Director can answer each of these questions with confidence and authority, you are ready to pass along the information needed by your District Deputy (who, by the way, is biting at the bit to get these data to his respective Diocesan Membership Coordinator or State Membership Director). **THANK YOU** for taking the time needed to complete this state-wide, Supreme-required Membership Recruitment report. And, **THANK YOU** for expanding Columbianism in your Parish(es) and Community(ies).

R.C.I.A.: An Untapped Source – Speaking of "potential candidates", when is the last time someone from your Council Membership Committee spoke with your Parish's Director (or Coordinator) of Religious Education (D.R.E. or C.R.E.)? The Rite of Christian Initiation for Adults (R.C.I.A.) program has begun or will shortly begin in Parishes throughout the State of Wisconsin. Now is the time to contact your Parish (or Parishes) D.R.E.s and/or C.R.E.s.

Why you may ask? Well, (1.) it is better to request an opportunity to speak with the R.C.I.A. candidates now than putting off your request until later, when it may be too late! And, (2.) what better way to introduce a newly converted Catholic Gentleman to practice his Catholic Faith than through the Knights of Columbus. By joining the K of C he will have the opportunity to live his Faith not only in the Church proper, but in his Community and daily life.
